- Notification of Appeal under Section 78 against the refusal of 3PL/2018/0016/F: Land to west of 2A Beeches Lane erection of detached dwelling. The Council to respond emphasising that their views have not changed and there is strong local opposition to the application. The lack of access and parking will have a significant impact on any tradesmen accessing the site as well as any future residents.

Outstanding Highways Issues

The Give Way signs at Church Road crossroad have been moved however the white lines still need repainting. **Clerk to chase.** 

The road next to the Hackford Road postbox is still badly subsiding. Clerk to chase Low Street ironwork still need levelling. Clerk to chase.

The 'flood warning signs' on the B1135 between Danemore House and Denmark house have still not been removed **Clerk to chase**.

The '10mph' loose stones warning signs near Hardingham Station have still not been removed. **Clerk to chase** 

The road from Hingham towards Vine Lodge was resurfaced last year and Ben Rayner, Highways Engineer had suggested that the road could be continued this year. There has been no further response

Ben Rayer also suggested resurfacing Mill Road however there has been no further information. The footpath next to The Grove. Low Street is overgrown and needs clearing **Clerk to report**. The fingerpost on the corner of Church Road and Middleton Road is loose and acts as a weathervane rather than pointing to the church. **Clerk to report**.

#### 12) Broadband update

It was noted that part of the Parish, including Church Road has fibre installed. Low Street is due to be live by the end of the year.
