Hardingham Parish Council - Annual Report - April 2022

The last two years have seen the Parish Council, like the rest of the country, having to navigate its way through various covid restrictions and this has, inevitably, had some impact on the way that we communicated and interacted with residents of the village.

As a consequence, last year's Annual Parish Meeting was conducted online via Zoom. It is therefore a pleasure to look forward to meeting again in person this year at the Memorial Hall on Monday the 9th May at 7:00pm. We attach a notice to that effect and hope that lots of you will be able to attend.

In addition to the Annual Parish Meeting, it is also great to see the village returning to normal activities with May and June offering various opportunities to come together and celebrate. In this regard, we also attach information on arrangements for the Platinum Jubilee celebrations in early June and it's a delight to see the Annual Village Fete back at the end of June.

Parish Business has very much continued over the past 12 months and set out below is a brief report on the key areas of activity:

General Reporting

Planning

We continue to receive information on all Planning Applications within the Village Boundaries, through Breckland Council who are the Planning Authority. Where appropriate, we seek feedback and views of residents, particularly neighbours and those in the close vicinity. We strive to remain objective and understand the views of both applicants and the wider village, before providing comments to Breckland Council.

In addition to specific applications, we liaise closely with Breckland Councillors over evolving Planning Policy, both at District, County and National government levels. Clearly, we are mindful here of the impact and implications of new policies on the village and its residents.

Highways

We maintain a close liaison with Norfolk County Council's Highways Team. This includes reporting and monitoring repairs (potholes, drainage problems etc).

We also consult them over such matters as speed limits, in which respect, we have lobbied for the introduction of new limits in certain parts of the village. This can be a frustrating process, as the

Highways Team operate against a strict set of criteria. We are advised that these criteria are currently under review and we will be monitoring this closely and seeking to provide further feedback.

In addition to road maintenance and management, we also liaise with the Highways Team over the maintenance of footpaths. We are fortunate to benefit from a fairly extensive network of public and permissive footpaths in Hardingham and the majority of these are well maintained. Where necessary, we will engage with Highways if any issues are encountered.

Maintenance and Upkeep

Unlike many parishes, the Parish Council does not own any land, but we do own various assets and contribute to the maintenance of other amenities. This includes:

- The Bus Shelter on High Common and bench adjacent to this.
- Grass and hedge cutting around the Memorial Hall
- Grass cutting around the Church
- Village Notice Boards Outside the Memorial Hall
- The Village Sign on High Common.

We are particularly grateful over the last year to our County Councillor, Ed Connolly, who has assisted us in securing funding from the County Council towards both a new bench, by the bus shelter and more latterly and in conjunction with the Memorial Hall Committee, new notice boards. We would also express our appreciation to Hardingham Farms for installing the notice boards.

Litter Picking

It is appropriate to record our huge appreciation to Nigel Ford and a number of residents who have rallied to Nigel's call and regularly undertake litter picks across the village. Thank you, Nigel, for organising this and to all of those who participate.

Annual Audit

The Annual Audit of Parish Council finances and activities will take place during April, with the details being shared on the website during May.

Connectivity

We seek to communicate with residents and promote some support and connectivity across the village community through several routes including:

Initiatives

We liaise closely with a number of stakeholder and interest groups on specific topics. This will include: Breckland Council, Norfolk County Council and our MP, George Freeman.

We also liaise with other parish councils where common challenges and issues are faced. This currently includes:

- An initiative with adjacent parishes to call for improvements to the B1135.
- An initiative to mitigate the impacts of a massive project across Norfolk to bring offshore
 windfarm energy inland. Whilst absolutely supporting sustainable energy projects, we are
 part of a group calling for an Offshore Transmission Network (OTN), rather than having this
 energy brought ashore through a huge infrastructure project, the associated construction
 works for which will have a wide range of environmental and disruptive influences across
 the county.

We will post updates on our website, from time to time as they become available and of course discuss these further in Parish Council meetings when appropriate.
